6 Treasurer Carole Oliver's Report and accounts for 2024/25

These were circulated before the meeting.

Carole mentioned the following points in addition to her Report:

- (i) the Accounts virtually break even.
- (ii) The cost of the Musical Director and Accompanists' salaries have increased Carole has been aiming for some time for their salaries to be brought into line with the guidance from the National Federation of Music Societies. She confirmed that they are now within the average range quoted on the website.
- (iii) Carole reminded everyone that the loss on the Baroque Concert was within the budgeted loss of £5000 authorised by the choir.

Sarah also reported that the Gift Aid situation is now almost sorted by the Cathedral Finance team – Carole confirmed that matters are now running smoothly within the team, and they just have one year's Gift Aid to catch up on. Now the choir generally receives the Gift Aid in the same month as the subscription in question is paid.

Finally, Carole made a plea for someone to come forward to succeed her as Treasurer. She has done the job for 12 years and would like a year just as a normal singing member before retiring! She promised to be close at hand to deal with any queries a successor may have.

There were no questions or queries on the Report and Accounts.

Subscriptions

Carole explained the Committee, has approved and recommended an increase in the annual subscription from £105 to £120 ie by just £5 per term. Still great value.
